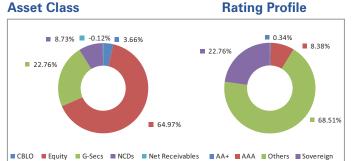

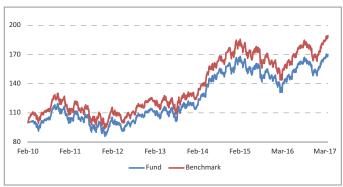

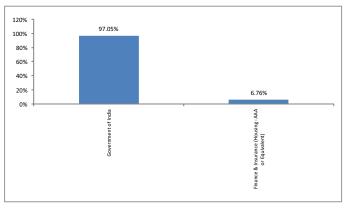


Asset Class Rating Profile

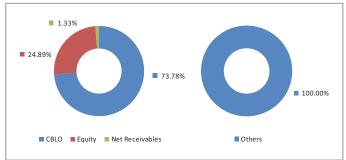

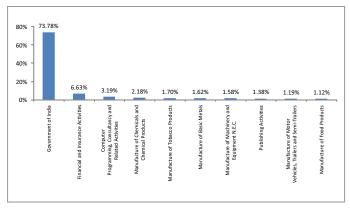
