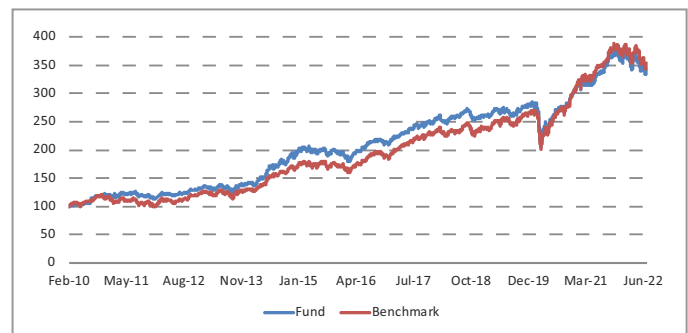

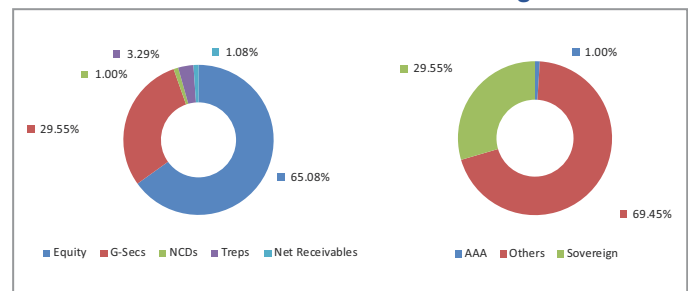

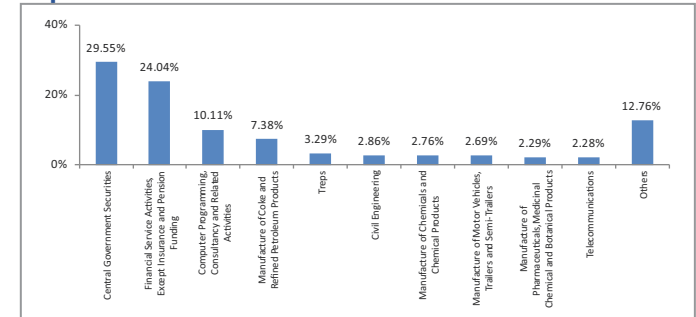


### Asset Class

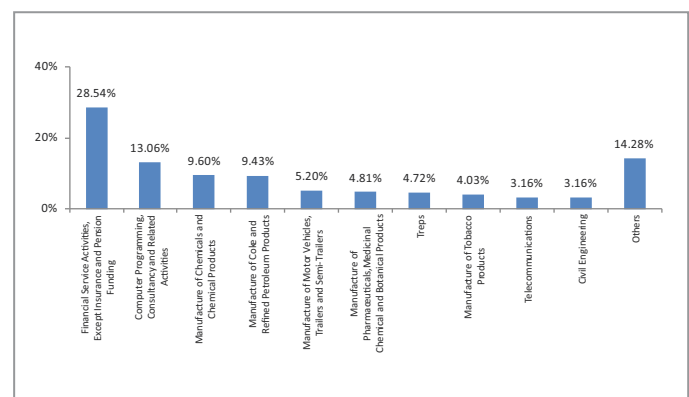

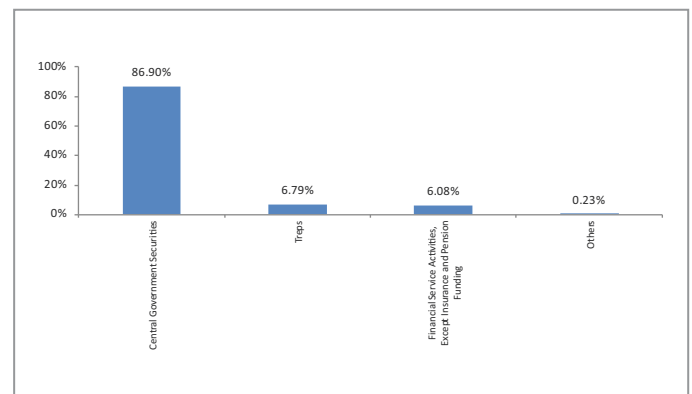

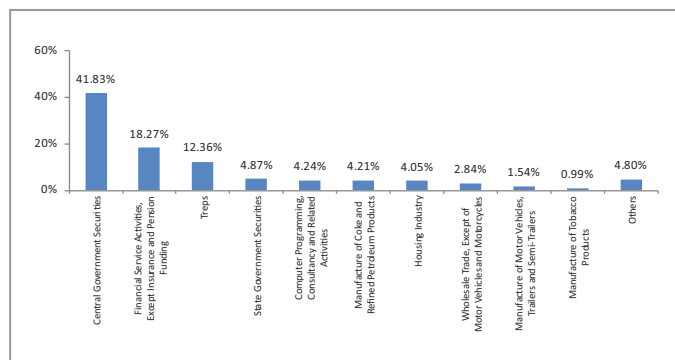


## Asset Class

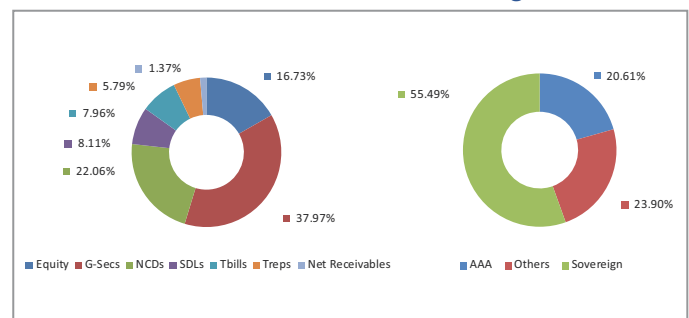

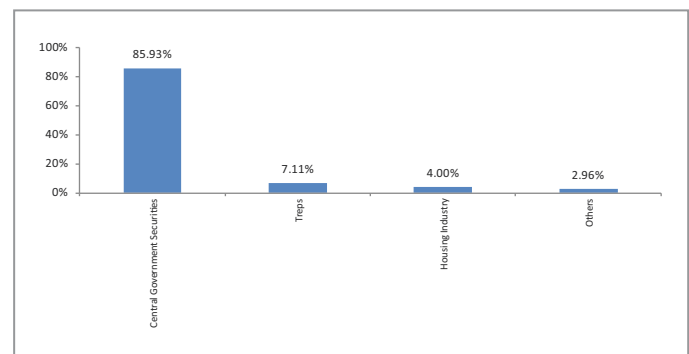
