Global bond yields including India fell sharply in Mar'23 following the banking crisis in the US and Europe. Most central banks increased interest rates in March, the Federal Reserve raised interest rates by another 25 bps to 4.75%-5% and, the highest level since September 2007. Uncertainties fueled by the turmoil in European and US banks, persisting inflation and continuing geopolitical tensions led stock markets to remain volatile.
